In 2012, we will celebrate the 100th Anniversary of Girl Scouting in the United States. To mark this milestone and honor our founder, Juliette Gordon Low, Girl Scouts of all ages are engaging in a nationwide, annual, signature community action project called "Girl Scouts Forever Green." While this theme can and should be widely interpreted for the purposes of planning and running program events in celebration of the 100th Anniversary, councils nationwide will emphasize events relating to environmental stewardship and sustainability. Long-time promoters and protectors of the environment, Girl Scouts envision being at the forefront of environmental sustainability, leading schools and communities in using resources wisely. - Community Action Projects: 2010-2011 and 2011-2012
- Celebrations: 2010-2011 and 2011-2012

Celebrate the 100th Anniversary with a Forever Green Event!

1. Come up with an amazing event idea!
2. Complete the Event Director & *Safety Activity Checkpoints* courses, if you have not already done so.
3. Meet the criteria established by the Celebrations Committee. The 100th Anniversary Celebration theme is "Forever Green". Your event must satisfy at least 1 additional criteria in addition to 100th Anniversary Celebration and Forever Green.
 - 100th Anniversary Celebration
 - Ideas may include carnival-like birthday parties and/or song fests, sing-alongs, concerts, etc.
 - Theme: Forever Green
 - Recruitment Event
 - Retention Event
 - Community Awareness
 - Service
 - Ideas may include tree planting, composting, environmental restoration, recycling, trash pickup, air quality, energy, water, green spaces, waste management, etc.
 - Other: _____
4. Additional qualifications for your Event:
 - Must be held on a date other than: a 100th Anniversary event run by the council, a similar 100th Anniversary event by another Service Unit (unless the events are a significant geographical distance apart).
 - See Calendar of already scheduled events on our website: www.GirlScoutsNorCal.org/forevergreen.
 - Cannot duplicate the council-run 100th Anniversary events, such as the Council-wide Camporee www.cadreamincamporee.org.
5. Organize an event committee and work with your Service Unit Coordinating Team to ensure that you are following local policy and guidelines.

Note: While this event is subject to approval by the 100th Anniversary Celebrations Committee, you must still complete the event approval process as outlined in the Event Director course. (Event Notification & Report Form, Financial Report for Events, Service Unit Approval, etc.).
6. **Complete the Girl Scouts 100th Anniversary Celebration Event Proposal Form at least 4 months in advance and prior to any event publicity (flyers, etc).**

 - The 100th Anniversary Committee Approval team meets monthly to approve events.
7. Approved?
 - You will be contacted by a committee member and advised of the status of your proposed event within 10 days of the 100th Anniversary committee meeting.
8. Once your event has been approved you can start your planning!
9. Enjoy your amazing, fabulous event!
10. Complete and submit GS NorCal's 100th Anniversary Event Summary.
